Indiana State Treasurer Kelly Mitchell Elected NAST President

Washington, DC – The National Association of State Treasurers (NAST) announced its 2021 leadership election results at today's virtual Annual Business & Membership Meeting. Indiana State Treasurer Kelly Mitchell will lead NAST as President starting January 1, 2021, succeeding current NAST President and Massachusetts State Treasurer and Receiver General Deborah B. Goldberg.

Kelly Mitchell was elected as the 55th Treasurer for the State of Indiana on November 4<sup>th</sup>, 2014 and elected to a second term in 2018. As the Chief Investment Officer for the State, she is responsible for the management of approximately eight to nine billion dollars on a daily basis.
